Letter from the Board Chair

Passing the Gavel

have had the privilege of serving the Forest Society as chair of the Board of Trustees since October 2019. When I took on the role, concurrent with the retirement of our long-time President/Forester Jane Difley, it did not occur to me that the next three years would be dominated by a pandemic with a resulting economic rollercoaster ride. We are very fortunate in filling Jane's shoes with Jack Savage, who has done an excellent job overall, especially in leading the Forest Society through the pandemic. As I come to the end of my three-year tenure as board chair, I want to thank our trustees, our staff, and most importantly our members for propelling us through truly extraordinary times.

My commitment to the Forest Society comes from an unflagging commitment to conserving land, the land we will need in New Hampshire in the decades to come to maintain a way of life we all value. Accomplishing that task requires us to be strategic and make prudent use of the funds our donors so generously gift us.

Among our accomplishments over the course of the last three years has been the Forest Society's ongoing response to the early 2019 fire at the Rocks in Bethlehem. When I took over as chair, the path forward seemed clear—we wanted to rebuild. But the pandemic forced us to test our assumptions and think carefully about our plans. Today, I am proud to have helped guide the Forest Society through the unknowns, and I am so pleased that we have completed the creation of a new outdoor amphitheater and "broken ground" on the renovation of the 1884 Carriage Barn to serve as our energy-efficient welcome center, community classroom, and offices for enhanced staffing north of the notches. We will accomplish more, including land protection, in the northern regions of our state by being more present.

The job is not done—we still need all your support to raise the rest of the capital necessary to realize this vision. But we are well on our way, and I'm confident we will achieve our goal.

While I can't predict what FY 2023 will bring and whether we might have to return to remote meetings and work, I am confident that the Forest Society, thanks to our supportive members, dedicated staff, ardent volunteers, and steadfast Trustees, will meet any challenge. We will continue to "perpetuate the Forests of New Hampshire" in the face of any obstacle. Thank you for your role in that endeavor.

121st Annual Report

Fiscal Year 2022 (May 1, 2021–April 30, 2022)

Dear friends,

A look back at our fiscal year reminds us that we continued to work under the restrictions of the COVID-19 pandemic for a significant amount of time. I'm pleased to report that despite those constraints, our conservation, stewardship, and outreach work advanced, and we can count FY22 as a productive, successful 121st year.

We enjoyed in-person work and gatherings in the summer and fall of 2021, including an outdoor annual meeting at Creek Farm in September. The resurgence of COVID variants over the winter sent us back to remote working and Zoom meetings. Come spring 2022, the situation eased, allowing us to hold our Cottrell-Baldwin Lecture Series in person in March, conduct maple programs at The Rocks, and even convene our Board of Trustees for an in-person board retreat in April (the first such gathering since May 2019), which focused on our organizational response to the changing climate.

In FY22, the board greenlighted the construction contract for converting the existing 1884 Carriage Barn at The Rocks in Bethlehem into a new classroom and Forest Society North welcome center for members and guests. To enhance our conservation, stewardship, and educational outreach north of the notches, Forest Society staff will also be able to work from newly constructed offices in the building. The project includes the installation of a solar array and geo-thermal heating, which will help achieve our net zero energy goal for the campus. We anticipate completion of the project in the summer of 2023, and we are more than halfway to raising the necessary capital of \$8.5 million. Thanks to all who have so generously supported the Forest Society North project so far.

As the included reports show, we finished FY22 in a solid financial position. Our balance sheet took a significant hit on our investments

year over year, as was the case for other organizations given the volatility of the stock market. Nonetheless, our annual revenues were strong enough to overcome those losses, thanks to generous bequests, a Paycheck Protection Program grant, and a bounce-back year for timber harvest stumpage and Lost River and The Rocks Christmas Tree sales. We also enjoyed modest gains in Annual Fund and membership income—we thank you, our members, for that!

In FY22, the Forest Society completed nine land protection projects covering 1,168 acres. This includes three additions to existing reservations of land in fee adding up to 267 acres and six conservation easements on 901 acres. Costs associated with these land protection projects, including the Morrill Farm in Boscawen and Clay Brook Forest in Hampton Falls, drove our year-over-year increase in expenses.

Among the easements was an Assets to Acres project made possible by long-time supporters Tim and Midge Eliassen, who donated 122 acres in Warren to the Forest Society with the intent for us to then sell that parcel subject to a conservation easement and use the proceeds of the sale to further our conservation mission. The Assets to Acres program has been a steady means to support our work. Thank you to the Eliassens and others who have contributed in this way over the years.

We grew our staff capacity for land protection in response to increased opportunities to accomplish strategically important work and our desire to work statewide. Projects in development include our largest ever, 3,700 acres in Shelburne, NH, among others.

Today, the Forest Society holds more than 760 conservation easements, deed restrictions, and executory interests on properties across the state, conserving more than 135,000 acres. To uphold the

conservation restrictions on lands owned by others, we conducted 377 ground monitoring visits and met with 185 landowners, in addition to monitoring our easements virtually using our industryleading satellite imagery.

Our more than 190 Forest Reservations constitute nearly 59,000 acres of conserved land that we own in fee. We manage these reservations sustainably, each with its own set of diverse goals, including recreational access and scenery; wildlife, air, and water quality; and carbon and renewable wood products.

Owning those lands demands that we steward them well, and we continue to dedicate significant resources to improving and expanding our efforts. The public's "rediscovery" of outdoor recreation during the pandemic has only emphasized the need to engage visitors to our lands, enlist their support in the care of the places they enjoy, and enhance their experience. In FY22, we focused on improvements at Mount Major, Mount Monadnock, and Creek Farm, which has emerged as an increasingly popular bright spot on the Seacoast.

Mount Monadnock represents our largest ownership at more than 4,500 acres, which we manage in collaboration with the state as part of Monadnock State Park. We renewed our agreement with the state in FY22, with an eye to focusing needed attention and resources to the stewardship of the reservation's trails that host more than 100,000 visitors annually.

There can be no doubt that a changing climate already affects our forests, from invasive species that threaten existing flora and fauna to weather patterns that influence when and how we conduct our forestry operations. Our staff and board have been working with professor Tony D'Amato's forestry research team at the University of Vermont to develop appropriate responses, including assessing carbon sequestration and storage in our forests, finding ways to reduce our organizational carbon footprint, and incorporating climate science in our educational outreach and advocacy. This is an ongoing initiative.

Our forestry staff worked with consulting foresters and loggers to implement 10 timber harvests in FY22 involving 550 acres, or about 1 percent of the acreage we own and manage. In addition to hosting multiple timber harvest tours, where participants learn about active forestry operations, we also worked in partnership with the University of New Hampshire and NH Timberland Owners' Association to create the popular Women in the Woods program for the growing number of women landowners and managers who want to learn more about chainsaw safety, tractors and machinery, and winter tracking.

We could not accomplish all that we do on our lands without assistance from the willing and capable hands of our many volunteers. In addition to attending more than a dozen workdays at our forest reservations last year, our volunteers are out monitoring our lands on a daily basis and deserve our thanks.

On the advocacy front, we supported the ultimately successful effort to include increased conservation funds, including \$700 million for the Forest Legacy Program, which funds protection of working forests, in the recently passed Inflation Reduction Act. We also worked with New Hampshire's members of the U.S. House of Representatives on the passage of the Recovering America's Wildlife Act, which sets aside \$1.4 billion nationally for projects to protect wildlife at risk of extinction from habitat loss.

At the State House, we engaged in efforts to create the New Hampshire low-grade timber and wood emerging market commission and a bill to establish a commission to study OHRV use in the state. The Forest Society and our conservation partners have a seat on the OHRV Commission.

In closing, I want to thank all of you who support our work, our dedicated Board of Trustees and committee members, and especially our staff. The Forest Society's work takes us across the state, seven days a week, and beyond the traditional 9–5 work-day hours. Our staff—your staff—are an incredibly dedicated group who care deeply about our mission and have made a career out of helping keep forests as forests. We couldn't accomplish what we do without them, and certainly without you who support our collective efforts.

Land Stewardship

Fiscal Year 2022 (May 1, 2021–April 30, 2022)

Coming out of the pandemic, the forestry staff was unsure of where markets would go. Softwood pulp markets continued to impact our ability to move low-quality pine harvests. The reduction in biomass markets has also impacted our ability to accomplish some habitat goals and work in very degraded stands to make improvement cuts. We've certainly shifted to a lot of cut-to-length operations, but there's still a need at times for biomass harvesting. The good news is that log markets remained high. As a result of people working from home, the demand for firewood continued to be strong and the mat log market has been phenomenal. It's a higher-value outlet for the very lowest grade sawlogs. Log markets were great for the year, which really helped us meet and exceed our stumpage goals. We implemented the following 10 timber harvests covering about 550 acres in all reaches of the state.

Habitat Projects

Habitat work at Heald Forest continued where we mechanically cut invasives to restore some fields and spot-treated invasives to give the native plants a leg-up. Work will continue at Heald in the future and our partners are interested in funding more of this important work.

Stewardship and Citizen Science

In partnership with the University of New Hampshire and New Hampshire Timberland Owners' Association, the Forest Society launched the Women in the Woods program to target a growing population of women landowners and managers. Several classes, including chainsaw safety, tractors for forestry, and winter tracking, were conducted and the program returned for a second year in FY23.

The Forest Society, through UNH, was also successful in winning a United States Forest Service Landscape Scale Restoration grant to help fund this new and popular initiative.

Education and Outreach

Fiscal Year 2022 (May 1, 2021-April 30, 2022)

Forest Society education and outreach programs included nearly 100 unique community-based events for more than 3,000 participants. Programs were based at Creek Farm in Portsmouth, The Rocks and Bretzfelder Park in Bethlehem, and the Concord Conservation Center, in addition to Mount Monadnock, Mount Major, and in cooperation with The John Hay Estate at The Fells in Newbury.

This year, the Forest Society transitioned from virtual programming to traditional, in-person programming designed to reconnect members, volunteers, and local audiences with the Forest Society's mission. Through lectures, guided hikes, readings, and tours, participants learned about natural resource topics, including forestry, land conservation, New Hampshire history, wildlife, recreation trails, and more.

The Forest Society also connected nearly 700 people with the natural world through two do-it-yourself challenges: the Merrimack Paddle Challenge and the 5 Hikes Challenge. Equipped with maps, interpretive information, and safety guidance, participants discovered the Merrimack River watershed, from New Hampshire to Massachusetts, and explored Forest Society reservations from the North Country to southern New Hampshire.

Easement Stewardship

Fiscal Year 2022 (May 1, 2021-April 30, 2022)

The Forest Society holds more than 760 conservation easements, deed restrictions, and executory interests on properties across the state that conserve more than 135,000 acres. The Easement Stewardship Department, consisting of a director, four easement stewards, and a land protection and stewardship coordinator, ensures that the purposes, natural resources, and other unique features of these conserved properties are protected in perpetuity. They achieve this by making ground visits to each property on a 1- to 5-year cycle, monitoring properties annually using satellite imagery, and collaborating with landowners and partners.

The Volunteer Easement Monitoring Program (VEMP) was started in 2016. In FY22, 17 VEMP volunteers conducted 48 monitoring visits, spanning more than 7,000 acres.

Conservation easements are collaborative partnerships between the Forest Society and private landowners. These collaborations yield a number of substantive stewardship opportunities, including permitted commercial and recreational activities as well as forestry and agricultural activities. Another essential element of the department's work is to enforce the terms of easements when violations occur, often not committed by landowners but by abutters or others. In FY22, there were 21 active easement violations, including four new violations identified, and six old violations were resolved.

Assets to Acres: How a House Lot Can Protect a Forest!

Through the Forest Society's Assets to Acres program, donations of property—such as houses, cottages, house lots, condos, or even undeveloped parcels of land—that are given with the intention that they be sold by the Forest Society are used to generate funds for purchasing conservation land or easements and providing for the stewardship and care of existing conservation land. Larger parcels of land may be resold, but with much of it conserved by a conservation easement. In FY22, Midge and Tim Eliassen donated one such undeveloped parcel of land that they never built on to the Forest Society. The Forest Society placed a conservation easement on 117 acres and sold the property with a 5-acre house lot in Warren. Thanks to the Eliassens, the proceeds of that sale will be used to purchase and care for future conservation lands. That's paying it forward! We are deeply grateful for their vision and generosity.
